Minutes

Minutes from the last board meeting were approved with one change, spell Coddens correctly.

Financial Report Discussion – Michael Sapper

- Operating cash decreased from 249,095 to 229,858
- Boosters account decreased from 5,974 to 2,974 due to purchase of Booster tents.
- Endowment account stayed the same, 10,142
- Restricted donations stayed the same at 26,503
- We are now using Quickbooks for a year so we can compare from year to year our financial position.
- Pockock is all paid off.
- Payroll is now being paid for through Quickbooks.

Executive Director Report Discussion – Angelia Thorpe

- Dashboard
 - Programs: Juniors and Masters programs are strong. Will need support in outreach areas.
 - People: No staffing concerns, training for coaches is current and doing a good job with succession planning.
 - Facilities: Equipment and boathouse in good shape. Working on docks and we made our goal of raising \$30,000 for the concrete pad. We are looking at designs from various dock companies. Still need some fundraising for docks.
 - Finance: all green
 - Fundraising: Need help in processes, short and long term goals.



Management/Operations

- Staffing: Coaching positions are open for Juniors and Master's programs.
- We need worker's compensation insurance. We found some coverage for employees when they are in the state of Indiana only.
- We renewed our US rowing membership and changed from a medium sized club to a large club. This increased our costs by \$1,000 per year.
- Insurance paid for our stolen dock.
- Safe sport updated their policy, so if anyone has interaction with youth more than 3 times, needs to be safe sport certified. IRC will be changing our policies to reflect this change.
- Pocock all paid off, now planning for next boat purchases.
- New tents and a booster trailer have been purchased.
- Evaluating fees for spring. We're looking at including an equipment fee for Master's of \$100 annually.

- Meeting with Big Ten to discuss 2023 championships and contract on Jan 23rd.
- Proposing a 2023 Holiday schedule for IRC staff
- Programs
 - Healthplex working out well, good location for majority of rowers
 - Survivor oars are back, they meet on Saturdays. They are training for competition in New Zealand this year.
 - We conducted a survey in December. We are evaluated it and results are being used to strength our programs.
- Fund development
 - Under 40,000
 - Great giving Tuesday campaign, made goal for concrete pad.
 - Juniors had an Erg-A-Thon to raise scholarship money. They broke a world record in the Women's U19 continual row category and raised \$1197.
- Events committee from 2022 will work on 2023. Will start meeting beginning of February.
